

Authorized 403(b) Provider List

Under the final Code section 403(b) regulations, a list of Investment Providers must generally be maintained by the Employer. The Plan incorporates this list into the Plan by reference. Because of this requirement in the final Code section 403(b) regulations, **a list of Investment Providers and Vendors must be consistently maintained and the Employer must coordinate information necessary for compliance with the final Code section 403(b) regulations among all Investment Providers and Vendors.**

This list identifies: 1) the providers approved for on-going contributions ("Investment Provider"); and 2) the former Investment Providers and vendors approved only for contract exchanges ("Vendor"), if any, available under the 403(b) Retirement Plan ("Plan") maintained by the plan sponsor ("Employer"), on or after the effective date of this list ("Effective Date"). Investment Providers and Vendors on this list will be subject to requirements and restrictions under the Plan provided however that such requirements and restrictions are not intended to enlarge the rights and benefits otherwise set forth in the product.

Types of providers for this form:

- **Investment Provider** — A provider who is authorized under the Plan to receive contributions (has a "payroll slot" with the employer's 403(b) plan).
- **Former Investment Provider** — A provider who was authorized to receive contributions after Dec. 31, 2004, but is no longer authorized under the Plan to receive contributions (does not have a current "payroll slot" with the employer's 403(b) plan).
- **Vendor** — A provider who is authorized under the Plan to receive a contract exchange, but is not authorized to receive contributions.

CURRENT INVESTMENT PROVIDERS UNDER THE PLAN

Select one of the two options below:

- GuideStone is the sole Investment Provider under the Plan.**

This means that no contributions will be made, were ever made, and/or funds ever transferred to a 403(b) Investment Provider or Vendor other than GuideStone for any participant in the Plan after Dec. 31, 2004. As the sole Investment Provider, information in GuideStone's recordkeeping system can be used to assure compliance with the 403(b) regulations as it relates to contributions, loans and hardship distributions.

- Current Investment Providers approved under the Plan.**

List below Investment Providers currently authorized to receive contributions under the Plan and whether hardships or loans can be made from the Investment Provider. To the extent such provision can be coordinated among Investment Providers and Vendors, the Employer can designate one Investment Provider, such as GuideStone, to process all hardships and loans; however, to the extent all of a participant's funds are not with GuideStone, the participant will have to transfer funds to GuideStone prior to the processing of the hardship or loan if those funds are to be included.
